The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

In accordance with Section 607.0203, Florida Statutes, the date when corporate existence shall commence shall be January 1, 1997, unless these Articles of Incorporation are filed after such date, in which case the date when corporate existence shall commence is the date of filing by the Secretary of State.
