**ARTICLE I - NAME**

The name of this Corporation is AUBERT PARTNERS, INC. and its address is 11767 S. Dixie Highway, #145, Miami, FL 33156.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
