Our Reinstatement Application, Annual Report/Uniform Business Report, and a check for \$300.00 for 1999 and 2000 fees are enclosed.

We were unaware that dissolution had occurred since no renewal form has been received by the corporation. Early in 1999, our Registered Agent, Dennis Roesle, left the corporation. Our attorney attended to legal requirements to release him from the corporation and we assumed he also filed the necessary information with the Department of State to remove him as Registered Agent. Since Mr. Roesle no longer is part of the corporation and no longer resides at his address of record, it is our belief that renewal forms were most likely mailed to him and then returned to your office as undeliverable. We apologize for the oversight in providing revised information to Florida Department of State and assure you the lapse was unintentional. We respectfully request that you consider waiving late fees for reinstatement.

We would appreciate it very much if you would expedite renewal of our corporation's filing. We are currently in the process of negotiating a loan for a new building and expansion of the business, and reinstatement is required as soon as possible. If we have not provided all necessary information or paid fees properly, we would be most appreciative if you would call our Administrative Assistant, Mary J.
