The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be ANDREW MOORE, INC.

ARTICLE II

This corporation is to have perpetual existence. The date of commencement of corporate existence shall be the January 1, 1997.
