ARTICLES OF INCORPORATION  
OF  
ATRA OCCUPATIONAL AND ENVIRONMENTAL SERVICES, INC

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be ATRA OCCUPATIONAL AND ENVIRONMENTAL SERVICES, INC.

ARTICLE II

This corporation shall exist perpetually.

ARTICLE III

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.
