2. Article I of the Articles of Incorporation of RKL Appraisal Services, Inc. was amended as follows:

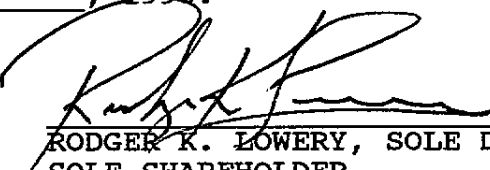
The name of this corporation is Fruitticher-Lowery Appraisal Group, Inc.
