ARTICLES OF INCORPORATION  
OF  
MASTER STEAMER USA, INC.

ARTICLE ONE

The name of the corporation is Master Steamer, Inc. The principle office is located at 4767 Northwest 103 Avenue, Sunrise, Florida 33351.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR


The aggregate number of shares which the corporation shall have authority to issue is 100 of the par value of dollars (\$1.00) each.
