2. The period of its duration is perpetual.

4. The corporation shall have authority to issue 100 shares, all of one class, \$1.00 par value.

Preemptive Rights shall be as follows: The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Shareholders, such of the shares of the stock of this corporation as may be issued for money (money, or any property or services) from time to time, in addition to that stock authorized (and issued) by the corporation.
