ARTICLE XI**AMENDMENT**

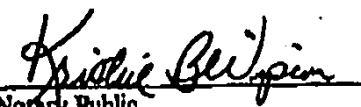

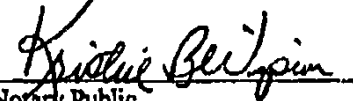
