ARTICLE I - NAME

The name of this corporation is: G & A Total Communications, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS

The principal place of business for this corporation shall be 3640 Terrapin Lane, Coral Springs, Florida 33067.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.


ARTICLE X - SUB-CHAPTER S AND CHAPTER 1244 PROVISIONS

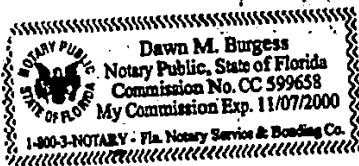


