### ARTICLE I

The name of the Corporation is: DEWAN TRADING, INC.

# ARTICLE II

The Corporation may engage or transact in any or all activity or business permitted under laws of the United States and the State of Florida. The corporation shall exist perpetually.

### ARTICLE III

### CAPITAL STOCK
