The undersigned, acting as incorporator(s) of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation.

First: The name of the corporation is John of All Traits, Inc.

Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are to transact the business and all other business not forbidden by law.

Fourth: The aggregate number of shares which the corporation shall have authority to issue 100 shares at one (\$1.00) par value.

Fifth: The address of the initial registered office of the corporation is 225 41 Ave. N. Petersburg, FL 33703 and the name of the registered agent at such address is John Lowe. The principal office of the corporation is 225 41 Ave. St. Petersburg, FL 33703.

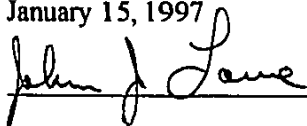
