Pursuant to Section 607.1003 of the Florida Business Corporation Act, SULPHURIC ACID TRADING COMPANY, INC. adopts these First Articles of Amendment to Articles of Incorporation:

**FIRST:** The name of the Corporation is SULPHURIC ACID TRADING COMPANY, INC.;

**SECOND:** Article III of the Corporation's Articles of Incorporation is deleted in its entirety and shall be replaced in its entirety by the following provision:

**ARTICLE III. CAPITAL STOCK**

The number of shares of capital stock that the corporation is authorized to issue is 1,000,000 shares of common stock, having a par value of \$1.00 per share.


