## FIRST ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SULPHURIC ACID TRADING COMPANY, INC.



Pursuant to Section 607.1003 of the Florida Business Corporation Act, SULPHURIC ACID TRADING COMPANY, INC. adopts these First Articles of Amendment to Articles of Incorporation:

FIRST: The name of the Corporation is SULPHURIC ACID TRADING
