The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### **ARTICLE I**

The name of the corporation is ARIAS & ASSOCIATES, INC.

### **ARTICLE II**

### **DURATION AND BEGINNING OF CORPORATE EXISTENCE**


