To Whom It May Concern:


I am the owner and president of Harmony Interiors, Inc. I formed my corporation in February, 1997. In the summer of 2006 I moved my corporate offices to a new address. I failed to inform the Division of Corporations of my new address.

Due to my move; I did not receive any copies of or any notices of my Uniform Business Reports. Since I did not receive any of these items I did not file with the Division of Corporations for my corporation for the years 2006, 2007 and 2008. I recently visited my attorney to ask a question about my corporation. He looked up the state records and informed me that my corporation had been "Administratively Dissolved".
