ARTICLE I

NAME

The name of this corporation is The Bullet Group, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 100 Dahlia Court, Ponte Vedra, Florida 32082.

ARTICLE III

CAPITAL STOCK




