Pursuant to the provisions of Section 607.1006, Florida Statutes, Vet Partners, Inc. (hereinafter to be known as VetPartners, Inc.), a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article One of the Corporation's Articles of Incorporation has been amended to read as follows:

"ARTICLE I

The name and initial address of this Corporation shall be: VetPartners, Inc., 7900 Glades Road, Suite 610, Boca Raton, Florida 33434, with the privilege of having its offices and branch offices at other places within or without the State of Florida."

SECOND: The foregoing amendment was adopted on August 29, 1997.

THIRD: The foregoing amendment was approved by the shareholders of the Corporation. The number of votes cast for the amendment were sufficient for approval. There were no voting groups entitled to vote separately on the amendments.
