The undersigned has executed the following Articles of Incorporation as incorporator under the laws of the state of Florida.

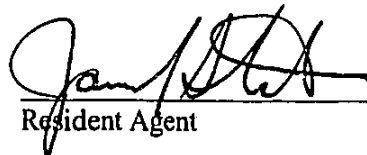
ARTICLE I. Name. The name of the corporation shall be Midway Park, Inc.

ARTICLE II. Term. The existence to the corporation shall commence upon filing of these Articles of Incorporation with the Office of the Secretary of State. The corporation shall have perpetual existence.

ARTICLE III. Purpose. The purpose of the corporation shall be to transact any and all businesses authorized by the laws of the state of Florida.

ARTICLE IV. Shares. The corporation shall be authorized to issue 100 shares of voting common stock which shall have a par value of \$1.00 per share.

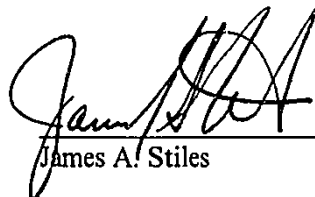

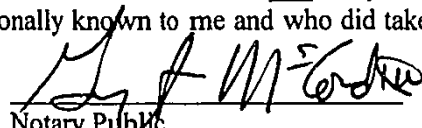

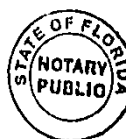
