I was recently informed by our accountant that our 2001 Uniform Business Report was never filed and that my corporation is now listed as "Admin Dissolution-for-Annual Report" as of 9/21/01.

In consideration of this I have enclosed the 2001 UBR report and the Corporate Reinstatement report, as instructed by your department. I was also advised to include only the \$150 filing fee (plus the \$8.75 certificate fee) along with my request for abatement of the additional fees for the following reason.

I respectfully request abatement of the additional fees for reinstatement due to the fact that we never received notification of non filing of the 2001 Uniform Business Report. In late December 2000 our physical location at 225 SW. 2nd Avenue, Homestead Florida was terminated. For undetermined reasons, any mail from your department was never forwarded to the company's current mailing address as shown above. Additionally, as of March 2001, the company engaged a new accounting firm. Our former accountant communicated to our new accountant that all required documents were filed for the Company by February 2001. The new accountant, upon receipt of the copies of all the documents filed by the former accountant, noticed that the 2001 UBR was not completed. Which is what has now prompted me to submitted these documents at this time.
