By these Articles of Incorporation and pursuant to Section 607.0202, Florida Statutes, the undersigned forms a Corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this Corporation is:

CARDINAL, CARLSON & PARKS ARCHITECTS, INC.

ARTICLE II

TERM OF EXISTENCE: This corporation shall exist perpetually and shall commence upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III

CORPORATE PURPOSE: This corporation may engage in every aspect of the business of rendering the same professional services to the public that an architect duly licensened under the laws of the State of Florida, is authorized to render. 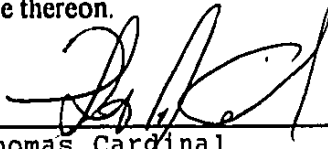
