ARTICLES OF INCORPORATION

OF

ALLEN & GOLDMAN, P.A.



The undersigned natural person, legally authorized to practice law in the State of Florida, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of the corporation is ALLEN & GOLDMAN, P.A.

ARTICLE II.

The period of the corporation's duration shall perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE III.
