

ARTICLES OF INCORPORATION OF



GALE D. LUCY, P.A.

The undersigned, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes for the practice of law, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is GALE D. LUCY, P.A. (The "Corporation").
