# ARTICLES OF INCORPORATION FILED 1144

The undersigned incorporator, being a natural person competent to contract for MASSEE, FLORIDA purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

# ARTICLE I

#### **ARTICLE II**

This Corporation shall commence upon the execution of these Articles and shall exist perpetually.
