Pursuant to the provisions of §607.1006, Florida Statutes, this Florida Corporation amends its Articles of Incorporation in its entirety as follows:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is Fajans Financial Services, Inc.. The principal office and mailing address is 103 Solana Road, Suite A, Ponte Vedra Beach, Florida, 32082.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.

ARTICLE 3.0 PURPOSE

The general purpose for which the Corporation is organized is to engage in insurance brokerage and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

ARTICLE 4.0 SHARES

The aggregate number of shares which the Corporation is authorized to issue is One Hundred Thousand (100,000) shares of common stock. Such shares shall have a par value of \$.01/100 per share. All such shares shall be common stock of a single class and possess the same rights with respect to all matters

ARTICLE 5.0 REGISTERED OFFICE AND AGENT




ARTICLE 8.0 ADOPTION OF AMENDMENT
