

the Florida General Corporation Act.


ARTICLE X = INDEMNIFICATION

the full extent permitted by law.

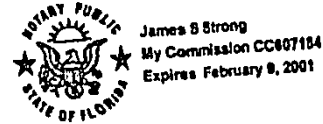
ARTICLE XI = AMENDMENT


