Article I

Beginning of corporate existence: This corporation shall have perpetual existence commencing on the date of filing of this Corporation.

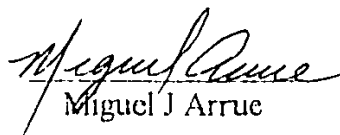

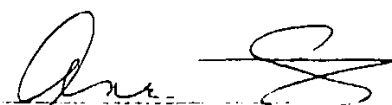
