ARTICLE I. NAME AND PRINCIPAL ADDRESS

The name of this corporation is GEOTECH RUBBER, INC.. The principal address of the corporation is P. O. Box 491356, 2620 West Industrial Street, Leesburg, Florida 34749-1356.

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the 8th day of April, 1997.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

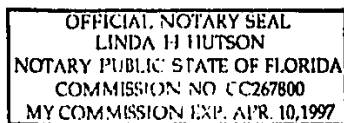




