

#### ARTICLES OF INCORPORATION

OF

#### CHARLES D. REGISTER, O.D., P.A.



The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

#### ARTICLE I-NAME

The name of the corporation is CHARLES D. REGISTER, O.D., P.A.

## **ARTICLE II - NATURE OF BUSINESS**

This corporation shall engage only in the practice of optometry, but may own and invest in property in accordance with Chapter 621, Florida Statutes. No person shall be a shareholder or director or officer of the corporation unless such person is licensed by the State of Florida as an optometrist.

# ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, each having the par value of \$1.00. The maximum number of shares shall be 5,000.

The amount of capital with which this corporation shall begin business is \$1,000. Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

# ARTICLE IV - TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### **ARTICLE V - ADDRESS**

The initial street address of the principal office of this corporation is to be at 5934 Brandon Lane, Port Orange, Florida 32127. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

#### ARTICLE VI - DIRECTORS

The business and the affairs of this corporation shall be managed by a Board of Directors, which shall be elected by the Shareholders and serve as provided in the By-Laws. The number of the members of the Board of Directors may either be increased or decreased from time to time by the By-Laws, but shall never be less than one (1). The corporation shall have 1 (one) director initially.

#### ARTICLE VII - INITIAL DIRECTOR

#### ARTICLE VIII - INCORPORATOR

#### ARTICLE IX - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 5934 Brandon Lane, Port Orange, Florida 32127, and the name of the initial registered agent of this corporation is Charles D. Register.

#### ARTICLE X - EFFECTIVE DATE

These Articles of Incorporation shall be effective and the corporation's existence shall begin when these Articles of Incorporation are received by the office of the Florida Secretary of State.

#### ARTICLE XI - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

#### **ARTICLE XII - BY-LAWS**

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.

#### **ARTICLE XIII - INDEMNIFICATION**

This corporation shall indemnify any officer or director or any former officer or director to the extent permitted by law.

## ARTICLE XIV - PREEMPTIVE RIGHTS.

The corporation elects to have preemptive rights as provided for by the Florida General Corporation Act.

#### ARTICLE XV - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders and approved at a Shareholders' meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the Shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

#### ARTICLE XVI - SHAREHOLDERS' AGREEMENTS

The shareholders may restrict the discretion of the Board of Directors in its management of the business of the corporation, or to otherwise place the provisions permitting restriction on the discretion of the Board of Directors in the management of the business of the corporation by the shareholders by way of a Shareholder Agreement executed by all of the shareholders. The Shareholders' Agreement is to be kept on file with the records of the corporation for examination by the shareholders.


