

7. A majority of the directors elect that the corporation be dissolved.



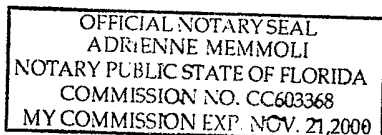


