ARTICLES OF INCORPORATION
OF
NLC HOLDINGS, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is NLC Holdings, Inc.

ARTICLE 2

DURATION

Section 2.1 Duration. This corporation shall exist perpetually. CAPITAL
