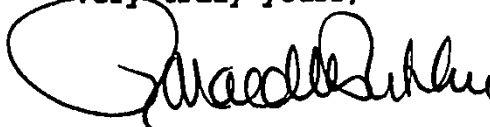

ARTICLES OF INCORPORATION

These Articles of Incorporation are made and subscribed for the purpose of organizing a corporation for profit under the Florida Business Corporation Act.

Article I - NAME

The name of this Corporation is FAITHQUEST, INC.

Article II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be:

Article III - PURPOSE

This Corporation is organized and formed to own, operate, manage and conduct the business of an Amway Distributorship, including the purchase and sale of Amway products on its own account, and the sponsoring, training and motivating of other distributors of Amway products; and for no other purpose.

Article IV - DURATION

This Corporation shall exist perpetually commencing on the date of the effectiveness of these Articles.

**Article V - CAPITAL STOCK**

This Corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock.

**Article VI - PREEMPTIVE RIGHTS**

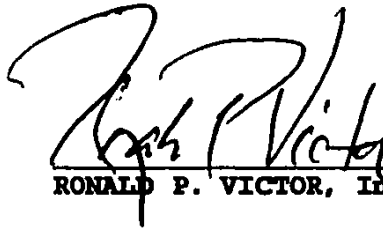

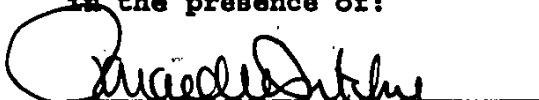
The power to alter, adopt, amend or repeal the By-Laws of this Corporation shall be vested in the Board of Directors.

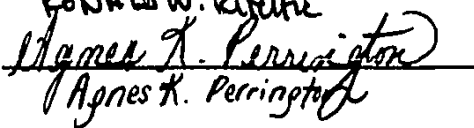

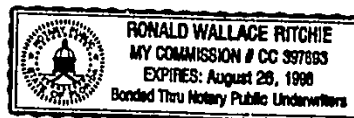
