ARTICLES OF INCORPORATION OF

We, the undersigned natural person(s), competent contract, acting as incorporator(s) of a corporation under the General Corporation Law of the State of Florida, make subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

ARTICLE I

NAME

The name of the corporation is:

The general nature of the business to be transacted is:
To engage in any activity or business permitted under the laws of the United States and of the State of Florida.




