



ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is: **SHEFFIELD PEST CONTROL, INC.**

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business as provided for in §607.0302, Florida Statutes.

ARTICLE III - CAPITAL STOCK
