The corporation shall be governed by bylaws adopted by the shareholders.

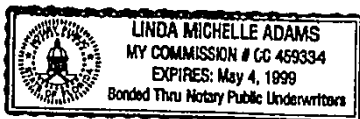


