ARTICLE I - NAME

The name of this corporation is AIRON CORPORATION located at 102 East New Haven Avenue, Suite 146, Melbourne, Florida 32901.

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

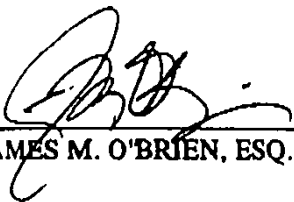

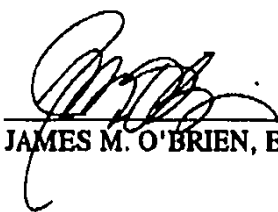
