ARTICLES OF INCORPORATION

OF

FILED

HP TWO HOLDINGS CORP., a Florida Corporation -6 PII 3: 08

I, the undersigned, being of legal age and a natural person, do hereby subscribe to lacknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the law of the State of Florida.

ARTICLE I NAME and PRINCIPAL OFFICE

The name of this corporation shall be HP TWO HOLDINGS CORP., a Florida Corporation, and the principal place of business and mailing address of this corporation shall be: 6262 Bird Road, Suite 3i, Miami, Florida 33155.

ARTICLE II DURATION

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III PURPOSE

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE IV CAPITALIZATION

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, every shareholder of this corporation shall have the pre-emptive right to purchase his pro rata share thereof at the price which it is offered to others, whether or not in excess of par. Fractional shares need not be issued on account of this provision.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be at <u>6255 Bird Road, Miami. Florida 33155</u>, with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be <u>Ignacio G. Zulueta</u>.

ARTICLE VI INITIAL DIRECTORS

The number of directors may be increased or decreased, but shall be not less than one, as specified by the shareholders from time to time. At any time, the shareholders may, by a majority vote, determine that the

corporation be managed by the shareholders.

ARTICLE VIII DIRECTOR CONFLICT OF INTEREST

- A. <u>Self dealing with the corporation</u>: No contract or other transaction between this corporation and any other corporation, and no act of this corporation, shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniarily or otherwise interested in, or are directors or officers of, such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that such director or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize any such contract or transaction, with like force and effect as if such director were not such a director or officer of such other corporation, or not so interested.
- B. <u>Dealing with other companies, persons or entities</u>: Without incurring any liability to the corporation or any of its shareholders, any director, officer or shareholder of this corporation may be an officer, director, shareholder or partner of any other entity or transact any business whatsoever with any other entity even where said other entity is in direct or indirect competition with this corporation. Furthermore, there shall be no obligation to disclose any such transaction or business arrangement to this corporation.

ARTICLE IX NO SHAREHOLDER LIABILITY

The private property of the shareholders shall not be subject to payment of the corporate debts in any extent.

ARTICLE X INDEMNIFICATION

This corporation shall indemnify its officers, directors and employees to the fullest extent permitted by law, either now or hereafter in effect.
