ARTICLE ONE

The name of the corporation is A.D.S. POWER SYSTEMS, INC. The principal address of the corporation is: 81 North Deerfield Ave., Unit#1, Deerfield Beach, Florida 33441.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations maybe incorporated under the Florida Corporation Act.
