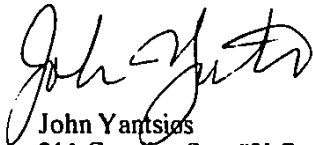

THE UNDERSIGNED subscriber to these Articles of Incorporation is a natural person competent to contract and form a corporation under the Laws of the State of Florida, and he does certify that he has become a corporation under and pursuant to the following Articles of Incorporation.

I.

The name of the corporation is **AKA CATERING, INC.**

II.

The corporation shall have all the powers given to it by the Laws of the State of Florida, now or hereafter, to conduct all legal business.

III.

The maximum number of shares that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) Shares of common stock with a par value of One (\$1.00) Dollar.

IV.

The amount of capital with which this corporation will begin business is Five Hundred (\$500.00) Dollars.

V.

This corporation is to exist perpetually.

VI.

The initial post office address of the principal office of this corporation is in the State of Florida, County of Brevard, at 211 Caroline St. #K-7, Cape Canaveral, FL, 32920. The Board of Directors may, from time to time, move the principal office to any other address in the State of Florida.

VII.

This corporation shall have one director initially. The number of directors may be increased or diminished from time to time, by By-Laws adopted by the shareholders, but shall never be less than one.

The name and address of the member of the first Board of Directors, who shall serve as Directors until the first annual meeting of the shareholders or until his successor is elected and shall qualify is John Yantsios, 211 Caroline St. #K-7, Cape Canaveral, FL, 32920

VIII.
