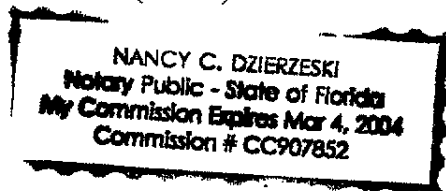
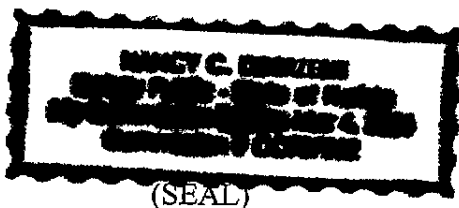
The name of the corporation Temp Power of Florida, Inc. shall be changed to COASTAL STAFFING SERVICE, INC., effective immediately.

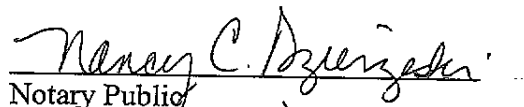
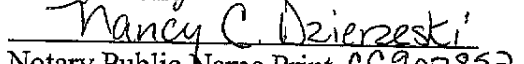
