ARTICLES OF INCORPORATION

These articles of incorporation are signed by the incorporator for the purpose of forming a profit, professional service corporation pursuant to Florida Statute Chapter 621 as follows:

ARTICLE I:

§ 1.1 Name

The name of the corporation is Toni A. Horne, P.A.

ARTICLE II:

§ 2.1 Address

The mailing address of the corporation is 1044 Castello Drive, Suite 102, Naples, Florida 34103.

ARTICLE III: PURPOSE

§ 3.1 Purpose

The purpose for which the corporation is organized is to render the practice of law to the public, which shall consist of consulting and rendering legal advice on any cause or matter whatsoever, including laws, statutes, rules, regulations, contracts, legal principles and other documents or relationships having legal effect; drafting documents and opinions for the purpose of implementing such advice, representation and arrangements; and preparing and managing the prosecution or defense of causes in courts or before other tribunals or agencies. This professional corporation shall exist and function in compliance with Florida Statutes Chapter 621, "Professional Service Corporations and Limited Liability Companies" and in order to properly prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of legal services.

ARTICLE IV:

§ 4.1 Authorized Stock

The total authorized stock is 100 common shares of \$1.00 par value per share.

ARTICLE V: NO NEED FOR ACTUAL STOCKHOLDER MEETING

§ 5.1 Majority Consent Voting

Any action required or permitted by Florida Statute Chapter 607 at an annual or special meeting of stockholders may be taken without a meeting, without prior written notice and without a vote if consented to in writing by the holders of outstanding shares having at least the minimum number of votes necessary to authorize or ratify such action if taken at a meeting at which all shares entitled to vote were present and voted. Prompt written notice of the taking of said action shall be given to the non-consenting stockholders by (among other methods) mailing said notice to said stockholders by first class mail, postage prepaid, to their address of record.

ARTICLE VI:

§ 6.1 Initial Directors

The initial board shall consist of one director whose name and address is: Toni A. Horne, 1044 Castello Drive, Suite 102, Naples, Florida 34103.

ARTICLE VII: REGISTERED OFFICE

§ 7.1 Registered Office

The address of the initial registered office is: 1044 Castello Drive, Suite 102, Naples, Florida 34103.

ARTICLE VIII: INCORPORATOR

§ 8.1 Incorporator

The name and business address of the incorporator is Toni A. Horne, 1044 Castello Drive, Suite 102, Naples, Florida 34103.

ARTICLE IX:

\$ 9.1 Term

The term of existence of the corporation shall be perpetual.

ARTICLE X: AMENDMENT OF ARTICLES OF INCORPORATION

§ 10.1 Amendments to Articles

The corporation may amend its articles of incorporation,

from time to time, so as:

- a. To change its corporate name.
- b. To change its period of duration.
- c. To change, enlarge or diminish its corporate purposes.
- d. To increase or decrease the aggregate number of shares, or shares of any class, which the corporation has authority to issue.
- e. To limit, deny or grant to stockholders of any class the preemptive right to acquire additional or treasury shares of the corporation, whether then or thereafter authorized.
- f. To increase or decrease the par value of the authorized shares of any class having a par value, whether issued or unissued.
- g. To exchange, classify, reclassify or cancel all or any part of its shares, whether issued or unissued.
- h. To change the designation of all or any part of its shares, whether issued or unissued, and to change the preferences, limitations, and the relative rights in respect of all or any part of its shares, whether issued or unissued.
- i. To change shares having par value, whether issued or unissued, into the same or a different number of shares without par value, and to change shares without par value, and to change shares without par value, whether issued or unissued, into the same or a different number of shares having a par value.
- j. To change the shares of any class, whether issued or unissued, and whether with or without par value, into a different number of shares of the same class or into the same or a different number of shares, either with or without par value, of other classes.
- k. To create new classes of shares having rights and preferences either prior and superior or subordinate and inferior to the shares of any class then authorized, whether issued or unissued.
- 1. To cancel or otherwise affect the right of the holders of the shares of any class to receive dividends which have accrued but have not been declared.
- m. To divide any preferred or special class of shares whether issued or unissued, into series and fix and determine the designations of such series and the variations in the relative rights and preferences as between the shares of such series.
- n. To authorize the board of directors to establish, out of authorized but unissued shares, series of any preferred or special class of shares and fix and determine the relative rights and preferences of the shares of any series so established.
- o. To authorize the board of directors to fix and
