

The undersigned, acting as the incorporator of a corporation under the laws of the State of Florida, does make subscribe, and acknowledge these Articles of Incorporation, pursuant to Section 55 of the Florida General Corporation Act, and other applicable provisions of the Corporation Law of the State of Florida, and acts amendatory thereof and supplemental thereto.

FIRST: The name of this corporation is **VERO BEACHSIDE NEWS, INC.**

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose of the corporation shall be to operate a newspaper and to engage in any lawful act or activity for which corporations may be organized under the corporation laws of this State.

FOURTH: The maximum number of shares which may be issued by the corporation is seven thousand five hundred (7,500) shares of one dollar (\$1.00) par value.

FIFTH: The street address of the principal office and the initial registered office of the corporation shall be 4625 North ALA, Suite 4, Vero Beach, Florida 32963.

SIXTH: The name of the initial registered agent at such address is David Walley.


