
ARTICLE I

The name of the Corporation is Mehran & Mamdani, Inc. The Corporation was formed as of May 22, 1997.


ARTICLE II

This Corporation, by the majority vote and approval of all of the shareholders in the Corporation, shall be dissolved as of July 20, 1997.


