**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
ADVANCED COMPUTER TECHNOLOGY AND SERVICES, INC.
(Document No. P97000045966)**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is ADVANCED COMPUTER TECHNOLOGY AND SERVICES, INC. (hereinafter referred to as the "Corporation").

Article II - Amendment

Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"The name of the corporation is CVTREK of Florida, Inc.

The principal place of business of the Corporation is 16801 Florence View Drive, Monte Verde, FL 34756."

The remainder of the Articles of Incorporation are unchanged and shall remain in full force and effect.

Article III - Effective Date of Amendment
