The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be MMMI, Inc.

The corporation shall commence its existence on May 29, 1997 and shall exist perpetually unless sooner dissolved according to law.
