ARTICLE I-NAME

The name of this Corporation is Beaches Obstetrical and Gynecological Practice, Inc.

However, amendments shall not become effective until ratified (i) by the shareholder of this Corporation, acting by the affirmative vote of at least three-fourths of the directors then in office of the shareholder, and (ii) solely in respect of amendments that change the mission and philosophy statement, by Baptist Health System, Inc. and Daughters of Charity National Health System - East, Inc.
