#### ARTICLES OF INCORPORATION

OF

MINH'S PLACE, INC.

### ARTICLE I - NAME:

The name of this corporation is: MINH'S PLACE, INC., hereinafter referred to as the "Corporation".

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE:
