The undersigned, for the purposes of forming a corporation under the Florida general. Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation is The Gasket Man, Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.

The price and terms at which, and the time within which such shares may be offered and resold shall be determined by an affirmative vote of 3/4 of the outstanding shares of this corporation.
