ARTICLE I - NAME

The name of this Corporation is BUSTA & SON'S CORPORATION initial address: 8562 Curry Ford Road, Orlando, Florida 32825.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on June 6, 1997.

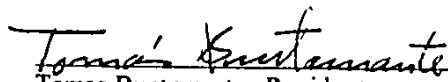

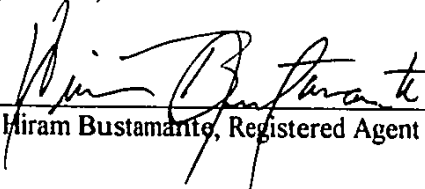

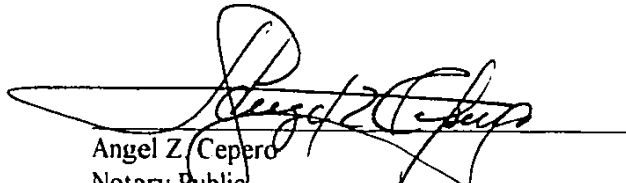
