ARTICLES OF AMENDMENT NO. ONE  
TO THE ARTICLES OF INCORPORATION OF

FIRST: The name of the Corporation is Renaissance Design Build Group, Inc.

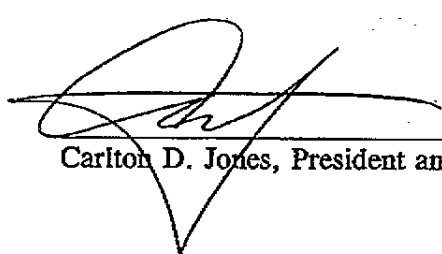
SECOND: The Articles of Incorporation shall be amended to delete Article I in its entirety and replace it with the following:
